The Local Wholesale Complete Agreement by and between BellSouth Telecommunications, LLC d/b/a AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA, AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI, AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA and AT&T TENNESSEE, Illinois Bell Telephone Company d/b/a AT&T ILLINOIS, Indiana Bell Telephone Company Incorporated d/b/a AT&T INDIANA, Michigan Bell Telephone Company d/b/a AT&T MICHIGAN, Nevada Bell Telephone Company d/b/a AT&T NEVADA and AT&T Wholesale, The Ohio Bell Telephone Company d/b/a AT&T OHIO, Pacific Bell Telephone Company d/b/a AT&T CALIFORNIA, The Southern New England Telephone Company d/b/a AT&T CONNECTICUT, Southwestern Bell Telephone Company d/b/a AT&T ARKANSAS, AT&T KANSAS, AT&T MISSOURI, AT&T OKLAHOMA and AT&T TEXAS, Wisconsin Bell, Inc. d/b/a AT&T WISCONSIN ("AT&T") (previously referred to as BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina, AT&T Tennessee, Illinois Bell Telephone Company d/b/a AT&T Illinois, Indiana Bell Telephone Company Incorporated d/b/a AT&T Indiana, Michigan Bell Telephone Company d/b/a AT&T Michigan, Nevada Bell Telephone Company d/b/a AT&T Nevada, The Ohio Bell Telephone Company d/b/a AT&T Ohio, Pacific Bell Telephone Company d/b/a AT&T California, The Southern New England Telephone Company d/b/a AT&T Connecticut, Southwestern Bell Telephone Company d/b/a AT&T Arkansas, AT&T Kansas, AT&T Missouri, AT&T Oklahoma, AT&T Texas, and Wisconsin Bell, Inc. d/b/a AT&T Wisconsin) and TNCI Operating Company LLC (f/k/a Trans National Communications International, Inc.) ("CLEC"), is hereby amended as follows.

WHEREAS, AT&T and CLEC are the Parties to that certain "Local Wholesale Complete Agreement" dated July2, 2009 (the "Agreement"); and

WHEREAS, Trans National Communications International, Inc. has changed its name to "TNCI Operating Company LLC", and wishes to reflect that name change as set forth herein.

NOW, THEREFORE, in consideration of the mutual promises contained herein, AT&T and TNCI Operating Company LLC hereby agree as follows:

- 1. This Amendment is composed of the foregoing recitals, the terms and conditions, contained within, all of which are hereby incorporated in this Amendment by this reference and constitute a part of this Amendment.
- 2. The Parties agree to reflect the name change from "Trans National Communications International, Inc." to "TNCI Operating Company LLC".
- 3. AT&T shall reflect that name change from "Trans National Communications International, Inc." to "TNCI Operating Company LLC" only for the main billing account (header card) for each of the accounts previously billed to Trans National Communications International, Inc. AT&T shall not be obligated, whether under this Amendment or otherwise, to make any other changes to AT&T's records with respect to those accounts, including to the services and items provided and/or

billed thereunder or under the Agreement. Without limiting the foregoing, TNCI Operating Company LLC affirms, represents, and warrants that the ACNA and OCN for those accounts shall not change from that previously used by Trans National Communications International, Inc. with **AT&T** for those accounts and the services and items provided and/or billed thereunder or under the Agreement.

- 4. Once this Amendment is effective, TNCI Operating Company LLC shall operate with AT&T under the "TNCI Operating Company LLC" name for those accounts. Such operation shall include, by way of example only, submitting orders under TNCI Operating Company LLC, and labeling (including re-labeling) equipment and facilities with TNCI Operating Company LLC. Any change in Carrier's name including a change in the "d/b/a", or due to assignment or transfer of this Agreement wherein only Carrier's name is changing, and no Carrier Company Code(s) (ACNA/CIC/OCN) are changing, constitutes a Carrier Name Change under this Section. For any Carrier Name Change, Carrier is responsible for providing proof of compliance with industry standards related to any Company Code(s), including notification of the name change to the appropriate issuing authority of those Company Code(s) as required. Carrier must submit the appropriate service request to AT&T\_to update Carrier's name on all applicable billing accounts (BANs), and Carrier is responsible for all applicable processing/administration and nonrecurring charges for each service request. Should Carrier desire to change its name on individual circuits and/or End User records, Carrier must submit the appropriate service request(s) to AT&T to update Carrier's name on individual circuits and/or End User records, and Carrier is responsible for all applicable processing/administration and nonrecurring charges for each service request.
- 5. The Parties agree to add Sections 19.1.3 and 19.2.5 of the General Terms and Conditions to the Agreement:
  - 19.1.3 delivered by electronic mail (email) provided CLEC and/or AT&T has provided such information in section 19.3 below.
  - 19.2.5 notice by email shall be effective on the date it is officially recorded as delivered by delivery receipt and in the absence of such record of delivery, it shall be presumed to have been delivered on the date sent to CLEC by AT&T. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement.
- 6. The Parties agree to replace Sections 19.3 of the General Terms and Conditions of the Agreement with the following:
