

Kentucky Revised Statute 74.020(7) (b) and (c) place responsibility for the regulation and promotion of water district management training programs with the Kentucky Public Service Commission. Since 2010, the Public Service Commission has developed and provided a course of instruction for newly appointed water district commissioners to comply with KRS 74.020(8).

Kentucky Public Service Commission Water Training Seminars consist of three parts:

- 1) Information Pertinent to All Water Utility Commissioners and Staff
- 2) Presentations Designed to help New Commissioners understand and perform their duties as state regulations require. This section focuses on basic utility operations and management.
- 3) The final section is directed towards returning commissioners and water staff. It contains up-to-date information on ever changing laws, regulations and hot topics of interest.

Dept. of Environmental Protection grants Continuing Learning Education Credits thru these programs. New Commissioners, Operators, and Engineers can earn up to 12 hours, returning commissioners may qualify for up to 6 hours. Kentucky Bar Association also recognizes these seminars for up to 12 hours of CLE. Please make sure to mark the desired CLE when registering.

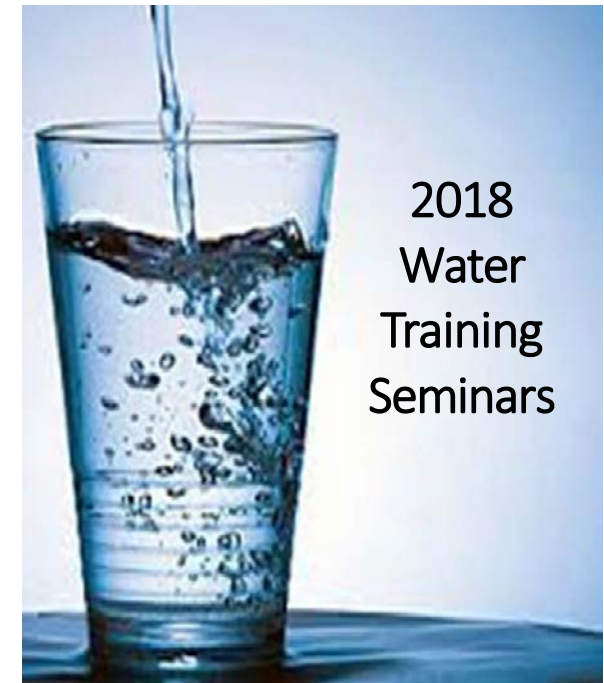
