O R D E R

On November 1, 1993, West McCracken Water District ("West McCracken") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. West McCracken purchases water from Paducah Water Works ("Paducah").

2. Effective August 1992, Paducah increased its rate for wholesale water from \$1.14 per 1,000 gallons to \$1.21 per 1,000 gallons. West McCracken did not elect to seek a purchased water adjustment at that time and has subsequently absorbed the increased cost of water.

3. West McCracken proposed to increase the rates to its customers effective December 1, 1993.

4. During the 12 months ending August 31, 1993, West McCracken purchased 81,124,900 gallons of water and sold 62,544,890 gallons.

5. West McCracken's calculations are correct and show an increase in purchased water cost of \$5,679, resulting in a purchased water adjustment of .09 cents per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to West McCracken customers will increase from \$20.55 to \$21.00, an increase of 0.0219 percent.

6. The purchased water adjustment of .09 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:



1. The purchased water adjustment of .09 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after December 1, 1993.

2. West McCracken's proposed tariff is approved.

3. Within 30 days of the date of this Order, West McCracken shall file verification that the notice to its customers has been given.
